



Blogging Mentorship Program Agreement and Terms

The Blogging Mentorship Program (the “Program”) by Fidelis Ozuawala (the “Mentor”) focuses on training across Niche Blogging and Arbitrage blogging. By joining the Program, you agree to the following terms and conditions:

1. Live Session and General Training

- The first session will be a LIVE one-on-one video call, which may be recorded. This session will guide you on how to set things up after you've met all the **prerequisites**.
 - After the initial session, video training links and written guides will be shared in the group to elaborate on and support the training.
 - The live session is capped at **2 hours maximum**. Any further guidance will be through group discussions and video materials.

2. Refund Policy

- **No Refunds:** Knowledge and training provided are irreversible; hence, no refunds will be issued under any circumstances.

3. Prerequisites

To participate in the Program, you must have the following:

- A fresh or verified **Google AdSense account with a domain attached**.
- An **advertising budget of N450,000 - N500,000 or more per month**.

Failure to meet these requirements may result in your inability to fully benefit from the Program.

4. Training Structure

- Training will be conducted either by the mentor or an associate member of the Program.

- After the live session, additional training materials will be provided in the group on a drip-feed basis to maintain the Program's pace.
 - Participants must not rush or demand accelerated delivery of content from the mentor or associates.

5. Communication Rules

- All complaints and inquiries must be made within the public group unless they involve sensitive data, in which case they can be sent directly to the mentor.
 - Respect must be maintained in all group interactions. Use of foul language, curse words, or insubordination is prohibited.
 - First offense: Warning issued.
 - Second offense: Removal from the group. Reinstatement will only be granted upon payment of 50% of the original mentorship fee.

- If you leave the group by mistake, you must provide a detailed explanation for your departure. Reinstatement is at the mentor's discretion.
 - **Content Confidentiality:** Materials shared within the group are strictly for members only and must not be distributed to anyone outside the group. Breach of this rule will result in immediate removal without reinstatement.
